As we explore opportunities for expansion, it is important that our community assesses all avenues of productivity and traditionality to ensure economic sustainability for our town.

- 9. What is local government's role in increasing broadband availability and reliability for the community?
 - As our community continues to evolve, the increasing reliance on technology has become apparent. The aging communication infrastructure in our area has led to disruptions in internet and communication services, particularly during inclement weather. While I do not believe it is the government's responsibility to ensure the reliability of technology, I do advocate for their support in facilitating growth and change within the private sector. Should the government choose to assume responsibility for telecommunication devices, it would necessitate a large expansion of their role, adding a separate class within their current infrastructure. This could lead to challenges in managing mass outages compared to the current diverse businesses providing these services.

 - I am unaware of the current restrictions that the Town faces. However, it is important to realize that we are in a frequent drought area. I feel in times of great duress, the town will need to monitor water usage and implement additional water right fees to the larger developing areas. The current water system was built during a time of small growth. With our large expansion in the last decade, I am sure there are strains on the water system that need to be addressed.

 - o I advocate for the Town to explore development strategies that prioritize workforce housing, taking into account varying income levels. The presence of high-value homes in our vicinity has led to an escalation in property prices, compounded by the Federal Reserve's increased interest rates, thereby posing challenges for the working class to afford homeownership. The provision of rental units, supplemented by government subsidies, with rents pegged to income levels, would be advantageous for our community. Given our area's reliance on seasonal tourism, many employment opportunities associated with this industry do not offer sufficient wages to sustain independent living.
